Environmental sustainability is a priority topic for Motorsport UK and earlier this year we launched the Environmental Sustainability Accreditation for all member clubs. The online course takes your club through the process of developing an Environmental Management System. Once completed, clubs have the opportunity to apply for the Motorsport UK Accreditation which, subject to an approval panel and a suitable environmental project, will enable you to apply for a grant of £250. We all know that the pandemic is far from over. However, you can be assured that Motorsport UK will continue to invest in our shared future and support for our member clubs is at the heart of this commitment.
